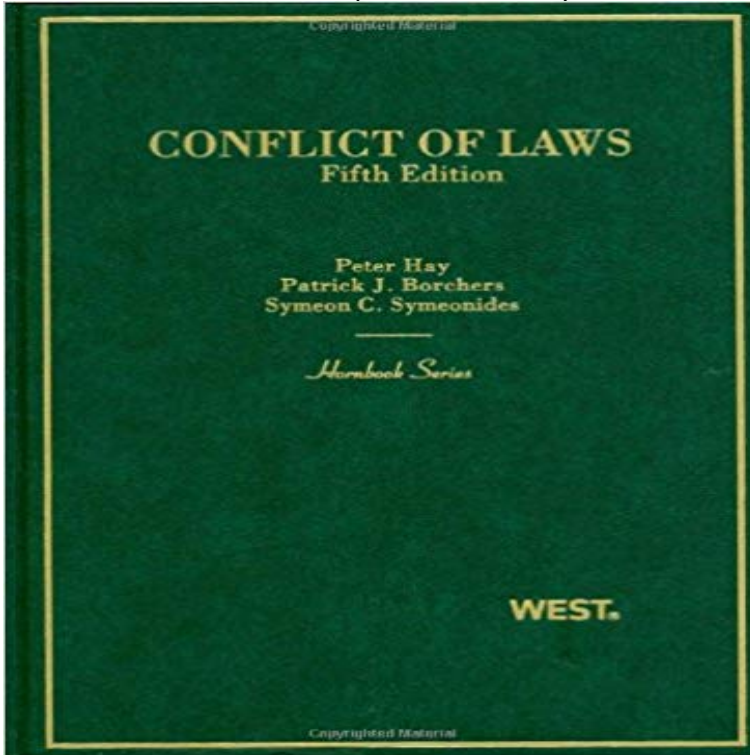


Conflict of Laws (Hornbook)
